Specifications Requirement:

e-Voting: means a process for recording votes by the members using a computer-based machine to display an electronic ballot and to record the vote and also the number of votes polled in favour or against such that the entire voting gets registered and counted in an electronic registry in a centralized server.

The software/ System should be a completely secure, transparent and easy-to-use voting system. It should be given an Immediate and accurate voting result. With the aid of software, it should be able to remove any mistakes occurring due to human error, like Invalid ballots or incorrect counting.

Members should be able to complete the election process within a few minutes through the Software/ System. The election commissioner should be able to declare immediate results once they initiate the results post-election closure, thus saving valuable time, effort and expenses towards counting.

The contract should include the complete scope of work requested, including objectives, procedures, identification of responsibilities, reporting and estimated fees and completion time.
