From the Desk of Dr. Upendra S. Kinjawadekar, IAP President 2023



Dear fellow academicians.

A very happy and healthy new year to all of you and your family. I'm overwhelmed with emotions as I write to you for the last time as President of Indian Academy of Pediatrics. Two emotions that top it all are the sense of pride and sense of satisfaction. I consider myself very fortunate having being given the mandate to lead this great organisation in its landmark Diamond Jubilee year. On the very first day on assuming office, we released a video stressing upon the importance of eco and environment friendly IAP. After spending three years in a row under the threat of the COVID-19 pandemic, 2023 was the first year when the entire world bounced back with newer zeal and enthusiasm and IAP was no exception. After almost four decades we had an opportunity to host the International Pediatric Association congress and after receiving great feedback from across the globe, I must say we indeed did a great job. Special kudos to congress president Dr Bakul Parekh, scientific chair Dr Santosh Soans, IPA President Dr Naveen Thacker and Org Sec Dr Chetan Trivedi. IPA Pedicon 23 was environment friendly in letter and spirit but we still need to put in a lot of efforts in this direction. Pedicon 23 also gave us an opportunity to honour our past presidents of IAP in front of the international community.

IAP is an organization that has made a deep impact on child health in India for the past many years. I truly believe that IAP is fulfilling its vision of improving child care with a focus on research, and honing our skills as pediatricians. Each day, we provide experiences and opportunities that are second to none. The cornerstone principles of excellence, accountability, transparency, and service-centeredness guide IAP till this day. For the year 2023, we had promised to keep our focus on 5 Ps i.e. Post graduates, Pediatricians, Parents, Publications and Partnerships. The pgREACH program targeted for training of the post graduates, ran 4 days a week throughout the year and similarly Academic pearls for the practicing pediatricians ran every Tuesday on a digital platform. While continuing with our commitment to complete NC-ECD and NRP programs, we introduced 10 new unique modules on topics as varied as Genetics, RACE (high risk newborn), Rheumatology (Rhytm), Understanding Lab tests rationale (ULTRA), Good practices and even Life beyond Pediatrics!

As a part of nationwide celebration of **Azadi ka Amritmahotsav**, IAP individually honoured and expressed its gratitude to its senior members who were born before independence with a certificate of recognition. FIT IAPan FITTER IAP, an online pan-India fitness competition held for increasing health awareness, received a huge participation in its very first year.

It is a proof that the greater the vision, the more winners it has the potential to attract. Today, our organization has more than 44,000 member pediatricians leading the way nationwide as we proactively seek out opportunities to integrate and coordinate our efforts locally, nationally, and internationally to create an impact in communities. Sankalp Sampoorna Swasthya (SSS) a school-based initiative targeted towards prevention of non-communicable diseases was launched in almost all the states of the country and I urge to each one of you to continue participating in this mission by spreading this awareness campaign in your region. B4E i.e. Breastfeeding-Early initiation, Exclusive, Every baby and Every place was yet another community outreach program launched this year and I'm happy to share that UNICEF partnered with IAP in conducting workshops across the state of Maharashtra as pilot project. Talking about partnerships, we also launched an HPV awareness program with the American cancer society and FOGSI, a Thalassemia prevention and care program with ECHO India and partnered with various state governments, ONGC, Apollo SHINE and Rotary for conducting SSS programs. Saksham was another initiative taken for increasing awareness about school age vaccination which is still lagging way behind

toddler immunisation. Through experts writing in nRICH (new Research In Child Health) we have tried to analyse and present some excellent articles published in reputed journals in a lucid format which is helpful for practicing pediatricians.

Our members are such involved and they want to be a part of something bigger than themselves. We can proudly say any member of this organization has a place where he or she can add value and when we provide effective leadership, it becomes the catalyst to make things happen, to effect change, to accomplish our mission, and to fulfil the vision of our mother body. The long-awaited constitutional reforms were accomplished in 2023, which have made IAP more inclusive of its members irrespective of the region they belong to.

The current era is digital, and slowly marching towards Al. Keeping pace with time, IAP has launched a CPR app which will be extremely useful even for laypeople to understand and use, and the Shishu Vikas app to help IAP members as well as parents to track and monitor the growth, neurodevelopment and even immunisation of newborn babies. IAP is always at the forefront of charitable activities. This year we have distributed 2 CPR mannikins to 50 branches each for training of its members and even teachers, policemen, firefighters, ambulance drivers etc. Prevention of violence against children was always on the top of IAP's agenda and we have kick started the zonal workshops for training of our members from East zone at Agartala, Tripura. In the month of December, we hosted the first pediatric obesity conclave in Mumbai where the new pediatric obesity guidelines were released. I'm delighted to share that the Transition of care guidelines of IAP are accepted by MOHFW and soon will be circulated across the country. Preconception care and new ACVIP 2023 recommendations on immunisation are some of the other very important publications made in the year. Friends we have so many members who apart from academics, practice and teaching are also excelling in different non-medical fields like community wok, farming, sports, music, arts etc. We tried to uncover these hidden gems and shared their inspiring stories from all 5 zones in 5 different issues of Child India.

During this year as president, I had tremendous support from all of you and I am both proud and honoured to say that we have moved proactively, transformed our efforts to our vision, remaining at the forefront as pediatric care givers nationwide.

As I conclude my message, I want to congratulate my friend and fellow leader Dr. Vineet Saxena, the honourable secretary general 2022-2023, treasurer Dr Samir Dalwai who was instrumental in resolving certain longstanding financial matters for IAP, and of course, the OB and EB board of 2023 for their value-added contribution and for maintaining order at the core of the organization. Honorary Secretary General Message, Dr. Vineet K. Saxena



Dear Esteemed Members of IAP.

It was an honour to be entrusted with the huge responsibility to steer IAP to greater heights and glory. If I could achieve our goals of combining academics with social outreach, it was because of the great team of IAP 2023 led by President Dr. Upendra Kinjawadekar and the efforts of our hardworking members. With great pleasure, I am presenting a brief report on the activities of central IAP in Academy year 2023.

This year it was a sign of great progress that our membership strength has raised to 44,143 by the year end from 40072 in January. We have updated 1600 member's personal details 98 branches registration details in our system this year. As IAP grows, now we have 1 Foreign Branch ,32 State Branches, 337 Local / City / District Branches across 5 zones of country,7 affiliations/ collaboration and 16 sub-committees in the year 2023 for furtherance of IAP 's aims & objects. IAP now has 22 Sub-specialty Chapters and 8 interest groups for promotion of Sub-specialties in Pediatrics and this year A Memorandum of Understanding is made between IAP and chapters/groups describes the proposed terms that will govern the collaboration. This MoU is signed by 13 Sub-specialty Chapters and 3 Groups so far.

During the year 2023 CIAP could successfully conduct 3 General Body Meeting, 5 Executive Board Meeting, 7 Office Bearers meeting and 131 other meetings. We now have 2 more added branches named Academy of Pediatrics Mayurbhanj and Villupuram Pediatric Society providing greater opportunities for our members to contribute to the cause of IAP. It gives me an immense sense of pride and respect as a fellow IAP member, to share the news that this year our academy has hosted the 30th International Pediatric Association (IPA) Congress and 60th Annual Conference of the Indian Academy of Pediatrics (IAP) which was held from 19th to 23rd February, at the Mahatma Mandir Convention and Exhibition Centre Gandhinagar, Gujarat, under the theme "Quality Care for Every Child Everywhere" and was attended by more than 6,500 delegates. This event has brought together several paediatricians, researchers, and healthcare professionals worldwide to discuss the latest advancements in Pediatric care, research, and education.

IAP has implemented one of its flagship program NC ECD programs with the support of Johnson and Johnson successfully and 168 NC ECD workshops were conducted altogether in this year. Also, I am happy to share that under our NRP programme 672courses were conducted and total of 19,819 health care providers were trained this year. The NRP programme basically involves, training of healthcare professionals and workers in neonatal resuscitation and essential new-born care to have at least one trained person at every delivery point.

Along with the flagship activities 13 new academic modules in various subspecialities floated in the year and kept the branches on toes. 537 workshops under these 13 modules were conducted under presidential action plan 2023. Our President invigorates the national initiative of IAP, SSS (Sankalp: Sampoorna Swasthya) programme by focusing the communities and conducting it as school-based, innovative, and holistic programme with high focus on prevention of noncommunicable diseases (NCD). More than 2 lakh beneficiaries have benefited under SSS programme in 2023.

It was a great honour and privilege that IAP was invited by American Academy of Pediatrics at their annual conference in Washington DC on 21st October 2023, in the Global Child Health Symposia. Our President Dr Upendra S Kinjawadekar presented IAP's various initiatives, in particular NC ECD and SSS programme.

With great pleasure and enthusiasm IAP as every year celebrated the annual day and week observances in 2023 as well and from this year the 2023 executive board tried to scatter activities throughout the year, so dates of IAP Days and Week Celebration has been revised. And as every year, this year also we saw our mother body taking initiative for the community and charity activities in a big scale. Relief fund donated to IAP Himachal Pradesh State Branch under 'Aapda Rahat' - to tackle natural calamities and CPR Mannequins distributions were the 2 main philanthropic works of IAP this year...

The regular flagship academic journals of Central IAP, Indian Pediatrics, The Indian Journal of Practical Pediatrics, and drug formulary were in full swing. Similarly, monthly e- newsletter of IAP 'Child India' is sent by mass e mail to all Members and every issue is archived on our website - www.iapindia.org . "Family Benefit Scheme" of Central IAP for providing financial help to the families served their mission to care and share with transparency and sincerity and has been a promising scheme this year too.

Central IAP have been able to provide a single point access to all IAP portals through the revamped IAP website and the introduction of the PEDCARD. The PEDCARD mobile app once installed on home screen can take to any IAP site or activity with a single click. Apart from this, the Pedcard will be offering loyalty services on purchase of academic subscriptions like Uptodate/ Clinical Key/ books from Jaypee Brothers and products of many hospitality and retailer industries in the near future.

This year IAP is privileged to award 'Honorary Fellowship of Indian Academy of Pediatrics (HFIAP)' to Prof. Aman Pulungan and Dr. Devendra Khandait and decided to nominate our 34 members for the Fellowship of Indian Academy of Pediatrics (FIAP) for the year 2023. These Awards has been bestowed based on the contributions they have given to the Academy as well as to the Child Welfare at large over the years.

I would like to conclude here congratulating and thanking my OB & EB Team 2023 as well as each one of my member friends for their tireless efforts and performance, support, guidance and most importantly the constructive criticism extended to the IAP Secretariat. I am certain that with the continued proactive involvement of my colleagues across the all-IAP branches, the IAP activities are soon to have maximum visibility in every nook and corner of the country.

Team 2024 under the vibrant dynamic President Dr G V Basavaraja is sure to take IAP to greater heights and ensure digital presence in all branches across the country. I hope you and your family are healthy and doing well.

First of all, let me thank President 2023, Dr Upendra Kinjawadekar, President 2022, Dr Remesh Kumar R, and President Elect 2023, Dr Basavaraj for their guidance and support in managing the treasury across the various Presidential Action Plans and other activities of IAP.

I am deeply thankful to our Secretary General, Dr Vineet Saxena, who was a huge pillar of strength and support. I am also grateful to Joint Secretary (Admin), Dr Purna Kurkure, Joint Secretary (Liaison) Dr Alok Bhandari, all Vice Presidents, Executive Board members 2023 and the Honourable Members of the IAP Finance Committee for their continued support and guidance to me, with regards to all the administrative responsibilities as National Treasurer. As of March 31st, 2023 - our Corpus Fund is Rs. 35 crores and the fixed deposits stand at Rs 47 crores. Whereas for the current year (2022-2023) our expenditure was Rs 43.83 crores against income Rs 50.41 Crores and consolidated surplus was 11.63 crores (After earmarked fund)

I congratulate incoming President 2024 – Dr Basavaraja, President Elect 2024 – Dr Vasant Khalatkar, all Vice Presidents, Secretary General – Dr Yogesh Parikh, Joint Secretary (Admin) – Dr Paramanand Andankar, Joint Secretary (Liaison) – Dr Ruchira Gupta, , and Executive Board members 2024. I am especially happy to welcome Treasurer 2024, Dr Atanu Bhadra and to relinquish charge of the treasury with my sincere commitment to support him in all his activities to ensure a smooth transition.

Confirmation of the minutes of the Annual General Body Meeting held on 21st March 2022 at Noida.

Secretary General, Dr. Vineet K Saxena informed the members that the e-copy of the Annual Report of the society was circulated to the members and hard copy of the same is distributed to the members present in the meeting. He invited their comments on the same. As there was no suggestion for alteration / addition / deletion in the minutes, the same were accepted unanimously.

2. Business arising out of the minutes.

Dr Nitin Shah raised the point that business arising from the minutes' agenda is an opportunity for discussing problems or questions from a previous meeting or status report should be addressed in the last meeting

Secretary General Dr Vineet Saxena appreciated the suggestion and assured that it will be implemented from next vear.

Consideration and adoption of Annual Report of the Society.

The Secretary General, Dr Vineet K Saxena informed the members that the hard copies of the Annual Report 2022 of the Society are circulated amongst the members for ready reference. The soft copy of the report was circulated amongst all the members by mass mail earlier on 3rd February 2023.

The same was accepted unanimously proposed by Dr Nitin Shah and Seconded by Dr B N Tripathi

4. Consideration and adoption of the audited Statement of Accounts for the year ended 31st March 2022 and the Budget for the year 2023-2024.

The Treasurer, Dr. Samir Hasan Dalwai presented the audited Statement of Accounts for the year ended 31st March 2022.

The Members discussed on the following points in the meeting:

Royalty from Publisher and Complimentary Copy of Book to Author:

Dr. Alok Gupta raised the point regarding the royalty from the publishers (Jaypee) and also suggested that a complimentary copy of the book should go to each author of the book as well. He asked for clarification on how the royalty was calculated and distributed among the authors.

Treasure, Dr. Samir Hasan Dalwai explained that the royalty was based on a percentage of sales and that it was divided equally among all authors who contributed to the book. He also agreed that complimentary copies should be given to the authors.

President, Dr Upendra Kinjawadekar appreciated the suggestion and agreed to consider it.

2) Utilization of the Property:

Dr Dhananjay Shah informed about the Kamdhenu Business Bay and Kailash Darshan property. He proposed to lease or selling of the 4th Floor of Kamdhenu Business Bay or Kailash Darshan property (one of them) and generate funds from it. He recommended to form a committee for this purpose.

President, Dr Upendra Kinjawadekar updated the house that the Kailash Darshan property was already rented out. He also said that the Kamdhenu Business Bay property was well utilized as office space for organizing programs like ToTs, workshops, book publication and small functions on the 4th Floor.

3) Pricing of the Books of IAP should be controlled by IAP.

The book pricing issue was discussed by the members, who felt that it was too high and made it hard to buy. They suggested that IAP should have some control over the prices of the books.

President, Dr Upendra Kinjawadekar told the house that all IAP books were available at discounted rates for IAP members. He also said that the books could be bought at lower prices using the IAP Pedcard portal.

4) Two FCRA Bank Account -

During the discussion some members have raised the points regarding Two FCRA bank Account, they have suggested that we should not have two accounts.

Treasurer, Dr Samir Dalwai Explained that The Foreign Contribution (Regulation) Amendment Act 2020 has been notified by the Central Government on 29th September 2020, to amend certain provisions of the Foreign Contribution (Regulation) Act 2010 (Act / FCRA). The Amendment Act substitutes section 17 of FCRA which required the recipient of foreign contribution to receive such amount only in an account designated as "FCRA Account" opened in a branch of the State Bank of India (SBI) at New Delhi. The legislative intent of the amendment appears to be to centralize the inflow and routing of foreign contribution, making it easier for the Government to monitor such contributions.

Government has now issued a notification on 7th October 2020, pursuant to which the Government has specified SBI, New Delhi Main Branch, 11, Sansad Marg, New Delhi-110001 as the branch for the purposes of the said sub-section.

Accordingly, FCRA registered persons/entities should get the FCRA Accounts opened with SBI, New Delhi Main Branch expeditiously before they can re-commence receiving any new foreign contribution. Thus, in order to comply with above amendment in the Law, IAP had to open second FCRA Bank Account with SBI-New Delhi Main Branch apart from its regular FCRA Account with Bank of Baroda.

1) Bank of Baroda - Opera House Branch - opened on March 17, 2010

2) State Bank of India - New Delhi Branch - opened on July 31, 2021

Presently the Bank of Baroda account is utilized for old fund. No fund is credited to this account after July 31, 2021.

5) Three Columns in Financial Statements

Treasurer, Dr Samir Dalwai briefed the house that for simplification purpose, the financial statements have 3 Columns as it helps to provide additional details in Breakup for Current Financial Year.

- First column shows Ledger wise amount
- Second column shows Consolidated/Group Total Amount
- Third column shows the Previous Year amount as required by Law.

6) Balance of Various Earmark Funds transferred to Single Ledger.

Members have raised the query regarding Balance of Various Earmark Funds transferred to Single Ledger. Dr Samir Dalwai explained that balances in various earmark ledgers were carried forward and lying unused for many years.

This would have raised question in future Income Tax Assessments. Thus, as per suggestion from Statutory Auditor, we have transferred all such Funds to single Ledger - "Various Fund for Action Plan" which shall be utilized in due course of time for various Action Plan Projects of IAP in coming three years i.e. 2023, 2024 & 2025.

7) **Explanation on Pedicon 2022- Advances**

Members raised the query about the Rs. 10,000,00/- as Pedicon advances. Treasurer, Dr Samir Dalwai explained that it is Pedicon bidding amount Rs. 5,00,000/- from IAP Twin cities branch and Rs. 5,00,000/- from IAP Cochin Branch.

Payable - Pending 8)

The said ledger is treated as Sundry account as there are many instances wherein payments details received from Members are incomplete and thus, we are not able to allocate such amounts to respective ledgers. As and when we receive information from Members, we transfer the said amount from this ledger to respective Ledger like Life Membership Fund, Admission Fund etc.

TDS Receivable - Rs. 3,26,34,750.69/-9)

IAP has filed Appeals against Income Tax orders for various Assessment Years. The said TDS Amount will be released by Income Tax Department after due-discharge of Appeal Orders. This matter has been discussed on numerous occasions at Finance Committee, Office Bearers Meeting and Executive Board Meetings.

10) Dr Nitin Shah suggested that the internal auditor or Charter Accountant of IAP should be present for the General Body Meeting to give more fiber inuts on members queries. Though a resolution to this effect was not passed, the President assured to continue this suggestion for next General Body Meeting.

1. Significant Accounting Policies The significant Accounting Policies followed by the trust are as stated below:

A) General

III. **AIMS AND OBJECTIVES**

The Aims and Objectives of the Society duly registered under the Societies Registration Act, XXI of 1860, Maharashtra State, bearing No. BOM 127/1963 GBSSD dated 3rd December 1963 and under Bombay Public Trust Act, 1950 (Bom. XXIX of 1950) at the Public Trust Registration Office of Greater Bombay Region, bearing No. F-1166 (Bom) dated 30th May 1964 are:

- To serve as advocates for Newborns. Children and Adolescents and help their families with reference to the attainment of optimal physical, mental, psychological and social health of Children and Adolescents up to 18 years of age.
- 2. To encourage and advance the knowledge, study and practice of the Science of Pediatrics in all possible ways.
- 3. To promote scientific collaboration amongst members and make guidelines regarding standards for their professional conduct as per the code of ethics of the Medical Council of India (MCI) / National Medical Commission (NMC) / equivalent National Statutory Body and as specified under the provisions of Code of Ethics of IAP.
- To organize, establish, conduct, superintend, control or assist the institutions for promoting directly or indirectly the practice, study and research in Pediatrics in any of its aspects by any appropriate means/platforms.
- 5. To establish and maintain libraries, reading rooms, laboratories and research centres for the promotion of its aims and objectives by any appropriate means/ platforms.
- 6. To provide facilities to members, students, and institutions for the study of or research in Pediatrics in any of its aspects by way of scholarships, fellowships, grants, endowments, etc...
- 7. To establish, maintain, or award fellowships, prizes, certificates, and diplomas of proficiency in the science of Pediatrics, and conduct professional tests, examinations, or other scrutiny as may be prescribed from time to time, either independently or in collaboration with other bodies.
- To print and publish official Journals of the Society, books, periodicals, or publications on Pediatrics and allied subjects which the Society thinks desirable for the promotion of its aims and objectives.
- 9. To organize Conferences, Lectures, Meetings, Seminars, CMEs, Exhibitions, and Training programs by physical and/or digital platforms, for the promotion of its aims and objectives.
